AGREEMENT

This agreement (the "**Contract**") is entered into on ___ 2023 by and between:

NOMAC Gulf Operation & Maintenance LLC, a limited liability company incorporated under the laws of the Emirate of Dubai in the United Arab Emirates with license No. 753941 and registered address in # 3403,34th floor, The One Tower, Tecom, Sheikh Zayed Road, Dubai, United Arab Emirates and commercial registration number 746579, United Arab Emirates , (hereinafter referred to as the "**Client**");

AND

Impex Power Solution FZ LLC, a limited liability company incorporated under the laws of the Emirate of Ras Al Khaima in the United Arab Emirates with Trade license # 5024509 and registered address in FDBC1038, Compass Building, Al Shohada Road, Al Hamra Industrial Zone-FZ, Ras Al Khaimah, United Arab Emirates , (hereinafter referred to as the "**Supplier**");

(The Client and the Supplier are hereinafter referred to collectively as the "**Parties**" and individually as a "**Party**".)

WHEREAS

- (A) The Client or its Affiliated Companies has selected the Supplier to provide supply and delivery of consumables at the Project Site in the manner described in Annexure A upon issuance of the relevant Purchase Order(s).
- (B) The Supplier has agreed upon issuance of the relevant Purchase Order(s) by the Client or its Affiliated Companies and undertaken to provide the Supply, as per the requirement and to the full satisfaction of the Client, in accordance with the terms and conditions of this Contract and based on the specification of the Purchase Order placed by the Client or its Affiliated Companies.

NOW THEREFORE, in consideration of the mutual covenants contained herein, the Parties agree as follows:

1. INTERPRETATION

1.1 Definitions

For the purposes of this Contract and the preamble above, unless the context requires otherwise:

- 1.1.1. **“Affiliate/s”** means any entity, or corporation, directly or indirectly, through one or more intermediaries, controlling, controlled by, or under common control with the Client.
- 1.1.2. **“Affiliated Companies”** means any of the Client’s Affiliates set out in Annexure B of this Contract.
- 1.1.3. **“Business Day”** means from Sunday to Thursday except any official public holidays that may fall within those days in the country having jurisdiction over the Client;
- 1.1.4. **“Client”** means the Client or its Affiliated Companies.
- 1.1.5. **“Contract”** means the agreement as contained in this document and any schedules, annexures or appendices attached to this document;
- 1.1.6. **“Contract Price”** means the fixed unit price payable to the Supplier through each PO as set out in Annexure A herein;
- 1.1.7. **“Confidential Information”** means in relation to each Party, all business, commercial, economic, financial, operational, technical, administrative, marketing, planning and staff information and data relating to it or to its interests whether in written, oral, electronic, pictorial or any other form and all information, data, know-how, formulae, processes, designs, photographs, drawings, specifications, software programs, samples and any other related material, whether or not such information is designated as “Confidential Information” at the time of its disclosure.
- 1.1.8. **“Effective Date”** means the date of commencement of this Contract which is agreed to be the date of signature of the Contract by the Parties;
- 1.1.9. **“HSE”** means health, safety and environmental policies, standards, procedures and requirements applicable to the provision of the Supply under this Contract as required by the Applicable Laws and regulations and as advised by the Client;
- 1.1.10. **“Intellectual Property”** means any and all confidential information, proprietary materials, inventions, developments, data, discoveries, improvements, ideas, concepts, data, computer programs, algorithms, protocols, systems and related documentation, and any other works of invention or authorship (whether or not patentable, copyrightable, or entitled to or eligible for other forms of legal protection) devised, written, invented, discovered, developed, or reduced to practice or tangible medium.
- 1.1.11. [Not used]

1.1.12. **“Prohibited Acts”** means any bribery, corruption or other prohibited act under the laws of the Kingdom of Saudi Arabia, the US Foreign Corrupt Practices Act, the UK Bribery Act, ICC Rules on Combating Corruption 2011, the laws of all other relevant jurisdictions and other requirements of national and international agencies, including acts such as the following:

- (i) bribery and corrupt practices, including the paying, offering, giving, receiving, agreeing to receive or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another Party, including a public official;
- (ii) fraudulent practices, including any actions or omissions, including misrepresentations, that knowingly or recklessly mislead, or are an attempt to mislead, another Party in order to obtain a financial or other benefit or to avoid an obligation;
- (iii) coercive practices, including impairing or harming, or threatening to impair or harm, directly or indirectly, any other Party or the property of any other Party in order to improperly influence the actions of a Party;
- (iv) collusive practices, including any arrangement between two or more parties designed to achieve an improper purpose, including improperly influencing the actions of another Party; and
- (v) obstructive practices, including, in relation to an investigation into allegations of bribery, corruption or other prohibited act: (A) deliberately destroying, falsifying, altering or concealing evidence that is material to the investigation; (B) making false statements to investigators in order to materially impede the investigation; (C) threatening, harassing or intimidating any other Party to prevent it from disclosing its knowledge of matters relevant to the investigation or pursuing the investigation; and (D) an act intended to materially impede access to contractually required information in connection with the investigation.

1.1.13. **“Purchase Order”** or **“PO”** means the individual order for Supply issued by the Client to be supplied and delivered by the Supplier under the terms and conditions of the Contract in accordance with the commercial terms included in the Purchase Order.

1.1.14. **“Project Site”** means any of the Project Site specified in Annexure B herein.

1.1.15. **“Related Party”** means:

- (a) Substantial shareholders of the Client;
- (b) members of the board of directors (the **“Board”**) of the Client or any of its Affiliates and their relatives;
- (c) Senior Executives of the Client or any of its Affiliates and their relatives;
- (d) Members of the Board or Senior Executives of Substantial Shareholders of the Client;

- (e) Entities, other than companies, owned by a member of the Board or a Senior Executive or their relatives;
- (f) Companies in which a member of the Board of the Client or a Senior Executive of the Client or any of their relatives is a partner or a shareholder;
- (g) Companies in which a member of the Board of the Client or a Senior Executive of the Client or any of their relatives is a member of its Board or is one of its Senior Executives;
- (h) Joint stock companies in which a member of the Board or a Senior Executive of the Client or any of their relatives owns 5% or more;
- (i) Companies in which a member of the Board of the Client or a Senior Executive of the Client or any of their relatives can influence their decisions even if only by giving advice or guidance;
- (j) any person whose advice or guidance influences the decisions of the Client, its Board and its Senior Executives; and
- (k) Holding companies or Affiliates.

1.1.16. **“Senior Executives”** means persons responsible for managing the daily operations of the Client, and proposing and executing strategic decisions, such as the Chief Executive Officer (CEO) and his / her delegates and the Chief Financial Officer (CFO)

1.1.17. **“Substantial Shareholder”** means a person holding five percent (5%) or more of the shares of the Client or voting rights therein.

1.1.18. **“Supply”** means the provision of equipment, tools, goods and/or other items in the manner set out in Annexure A herein;

1.1.19. **“Technical Specifications”** a set of requirements describing the features which the Supply should meet as provided by the Client described in Annexure A to this Contract.

1.1.20. **“Writing”** means legible writing and in the English language.

1.2. General Interpretation

For the purposes of this Contract, the following rules interpretation shall apply, unless otherwise provided by this Contract and/or the context requires otherwise:

1.2.1. a reference to any one gender, whether masculine, feminine or neuter, includes the other two genders;

- 1.2.2. any word or expression defined in, and for the purposes of, this Contract shall, if expressed in the singular, include the plural and vice versa, and a cognate word or expression shall have a corresponding meaning;
- 1.2.3. references to a statutory provision include any subordinate legislation made from time to time under that provision and references to a statutory provision include that provision as from time to time modified or re-enacted, as far as such modification or re-enactment applies, or is capable of applying, to this Contract;
- 1.2.4. references in this Contract to “clauses” and/or “schedules” and/or “annexures” and/or “appendices”, are to clauses and/or schedules and/or annexures and/or appendices (as the case may be) to, this Contract;
- 1.2.5. words and expressions defined in any law which is referred to in this Contract and which are not defined in this Contract shall, if and in the context and/or in relation to that law, have the same meanings in this Contract as those ascribed to them in that law;
- 1.2.6. any word and expression defined in any clause shall, unless the application of the word or expression is specifically limited to the clause in question, bear the meaning ascribed to the word or expression throughout this Contract;
- 1.2.7. if any provision in a definition is a substantive provision conferring a right or imposing an obligation on any Party them, notwithstanding that it is only in a definition, effect shall be given to that provision as if it were a substantive provision in the body of this Contract;
- 1.2.8. the use of the word “including” followed by a specific example, or examples, shall not be construed as limiting the meaning of the general wording preceding it, and the *eiusdem generis* rule shall not apply in the interpretation of such general wording or such specific example or examples;
- 1.2.9. if any period is referred to in this Contract by way of a reference to days, weeks, months, years or other intervals, the period shall be reckoned exclusive of the first day and inclusive of the last day, unless the last day falls on a day which is not a Business day, in which case the last day shall be the next succeeding Business day;

1.2.10. any reference to days (other than Business days), months or years, shall be a reference to calendar days, calendar months or calendar years, as the case may be;

1.2.11. no provision of this Contract shall constitute a stipulation for the benefit of any person who is not a Party to this Contract;

1.2.12. words or expressions having a meaning which is similar to any word or expression which is defined in this Contract shall have the same meaning as the word or expression which is so defined.

1.3. Headings and sub-headings

All headings and sub-headings in this Contract are for convenience only and are not to be taken into account for the purposes of interpreting it.

2. PROVISION OF SUPPLY

The Supplier agrees to provide the Supply to the Client in accordance with the terms and conditions of this Contract and the Purchase Orders.

3. TERM OF CONTRACT

3.1. This Contract shall commence on the Effective Date and continue for a period of (3) years unless terminated by either Party in accordance with the provisions of clause 18.

3.2. Unless otherwise specified in the Contract, all Supply shall be delivered to the location of the Project Site as specified herein. Delays in provision and/or delivery shall be reported immediately by the Supplier to the Client. The Client reserves the right to terminate the Contract immediately, should the Supplier fail to provide the Supply in accordance with this Contract and/or the Purchase Order (s). Supply shall be delivered on the days, between the times instructed by the Client in each Order.

4. CONSIDERATION FOR SUPPLY

4.1. In consideration of the proper provision and delivery of Supply and remedying of defects therein, the Client covenants to pay the Supplier the Contract Price as specified in Annexure A to this Contract or in accordance with the specific Purchase Order placed.

4.2. Payment Terms

- 4.3. All payments due to the Supplier by the Client in terms of this Contract are to be paid directly to the Supplier and the following terms apply:
- 4.3.1. All payments for Supply are to be paid within thirty (30) days from the date of the invoice and unless the Client disputes such invoice in which case payment shall be made only for the undisputed portion of such invoice and the disputed portion shall be settled between the Parties through amicable negotiations.
 - 4.3.2. Issued invoices will be available for dispute for a period of fourteen (14) days from the date of issue, after which the invoice will be regarded as final and no further disputes will be accepted.
 - 4.3.3. All payments in terms of clause 4.1 are to be paid into the nominated bank account of the Supplier in Emirates Islamic Bank, Account Number: 3708438142401, IBAN Number: AE500340003708438142401.
 - 4.3.4. Proof of payment is to be emailed to the Supplier at the email address nominated by it in clause 21.1 below on the date on which the electronic funds transfer is effected by the Client.
 - 4.3.5. The Client may set off against any payment for Supply any sums owed to the Client by the Supplier.

5. TAXES AND DUTIES

The Supplier shall be entirely responsible for all taxes (except VAT), levies, duties, permit fees, license fees or any other charges incurred until delivery and passing of title of the Supply to the Client.

6. RISK AND TITLE

Risk and title of the Supply shall pass from the Supplier to the Client upon acceptance of the Supply by the Client at the Project Site in the issued Purchase Order and the payment is received by the Supplier.

7. PERMITS, APPROVALS AND LICENSES

Whenever provision of the Supply requires the Supplier to obtain permits, approvals and import and other licenses from local authorities, the Client shall, if so required by the Supplier, make its best effort to assist the Supplier in complying with such requirements in a timely and expeditious manner.

8. OBLIGATIONS OF THE SUPPLIER

8.1. The Supplier will, in accordance with all Applicable Laws and regulations, be deemed to have full knowledge and have obtained all necessary information and data of Client facilities at which the Supply is to be delivered, including, where applicable, prevailing location, physical conditions, hygienic state, access, contingencies, risks and all other circumstances that may influence or saddle the delivery of the Supply.

8.2. Delivery and Documents:

8.2.1. The Supplier shall be entirely responsible for the provision, including delivery, of the Supply at the final destination which, under this Contract, is the Project Site.

8.2.2. Delivery of the Supply shall be made by the Supplier in accordance with the terms specified in the Purchase Order. The details of shipping and/or documents to be furnished by the Supplier pursuant to Annexure A.

8.3. Packing and Marking:

8.3.1. The Supplier shall provide the packing of the Supply as is required to prevent its damage or deterioration during transit to the Project Site. The Supplier shall be solely liable for any damage or deterioration to the Supply during transit and the Client reserves the right to refuse any damaged and/or deteriorated part of the Supply upon their arrival at the Project Site. The packing of Supply shall be sufficient to withstand during transit, without limitation, rough handling, exposure to extreme temperatures, precipitation and open storage.

8.3.2. The packing, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided in the Contract and Applicable Laws, including all additional requirements and subsequent instructions provided in the Purchase Order.

8.3.3. The Supplier shall ensure that adequate liability insurance is maintained at all times. The Supplier shall take out such insurance as required hereunder with an insurance company in respect of its liabilities herein and to fulfill any requirements of government or other appropriate bodies and will produce evidence of the relevant policies of insurance and receipts evidencing payment of current premiums and any other information the Client may reasonably require.

9. STANDARDS

The Supply provided under this Contract shall conform to the standards mentioned in the Technical Specifications, and, when no applicable standard is mentioned, to the authoritative standards appropriate to the Supply's country of origin. Such standards shall be the latest issued by the concerned local authority in the country of the Project.

10. INSPECTION AND TESTS:

- 10.1. The Client or its representatives shall have the right to inspect and/or test the Supply to confirm its conformity to the Technical Specifications at no extra cost to the Client. All required inspection and tests shall be listed in the Technical Specifications enclosed to this Contract. The Client shall notify the Supplier in writing, in a timely manner, of the identity of any representatives retained for these purposes.
- 10.2. The Client shall bear all of its own costs and expenses incurred in connection with inspection and testing including, but not limited to, all traveling and board and lodging expenses.
- 10.3. The Client may require the Supplier to carry out any tests/or inspection not required by the Contract but deemed necessary to verify that the characteristics of certain parts of the Supply are in compliance with the Technical Specifications under the Contract, provided that the Supplier's reasonable costs and expenses incurred in the carrying out of such tests and/or inspection shall be added to the Contract Price.
- 10.4. Should any inspected or tested Supply fail to conform to the Technical Specifications, the Client shall have the right to reject such Supply, and the Supplier shall either replace the rejected Supply or make alterations as necessary to meet the specification requirements free of cost to the Client. The costs of any repeated tests and/or inspection necessitated by the failure of the Supply to pass the inspection will be to the Supplier's account and deducted from the sums due to the Supplier and the Contract Price reduced accordingly.
- 10.5. Any inspection and tests undertaken shall in no way relieve the Supplier of any of its obligations under this Contract.

11. LIQUIDATED DAMAGES

- 11.1. With the exception of force majeure events described in this Contract, if the Supplier fails to deliver any or all of the Supply within the period(s) specified in the Contract, the Client shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, zero point one(0.1) per cent of the Purchase Order Price for every day's delay, up to a maximum of five(5) per cent of the Purchase Order Price.
- 11.2. The payment or deduction of such damages shall not relieve the Supplier from the obligation to complete the Supply, or from any other of his obligations and liabilities under the Contract.
- 11.3. The liquidated damages for delay have been calculated, and are acknowledged and accepted by the Supplier, as a genuine pre-estimate of the loss likely to be suffered by the Client as a result of a delay in the completion of the Supply. If for any reason such liquidated damages are found to be void or unenforceable, the Client shall be entitled to recover from the Supplier the actual losses suffered by the Client as a result of the delay.

12. WARRANTY

- 12.1. The Supplier warrants that the Supply provided under this Contract shall have no defect, arising from any act or omission of the Supplier, that may develop under normal use of the supplied Supply in the conditions prevailing in the Project Site;
- 12.2. The Supplier warrants that the Supply, design, materials, documents and methods provided by the Supplier, do not infringe any Intellectual Property rights;
- 12.3. Where applicable, in addition to the warranty provisions in this clause, the warranty shall remain valid for the period provided by the original manufacturer;
- 12.4. The Client shall notify the Supplier in writing in case there are any claims arising under this warranty;
- 12.5. Upon receipt of such written notice, the Supplier shall within twenty-one (21) days expeditiously repair or replace the defective Supply or any portions thereof at no cost to the Client;
- 12.6. In the event that the Supplier, having been notified, fails to remedy the defects within twenty-one (21) days, the Client may proceed to take such remedial action as may be necessary, at the Supplier's risk and cost and without prejudice to any other rights which the Client may have against the Supplier under the Contract;
- 12.7. Any delay from the Supplier's side to remedy the defaults beyond the twenty-one (21) days shall be considered liquidated damages in accordance with rates stated in Clause 11 of the Contract.

13. LIABILITY AND INDEMNITY

- 13.1. Except in cases of criminal negligence or willful misconduct, and in the case of infringement of Intellectual Property:
 - 13.1.1. The Supplier shall not be liable to the Client, whether in the Contract, in tort or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Supplier to pay liquidated damages to the Client; and
 - 13.1.2. The aggregate liability of the Supplier to the Client, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of returning or replacing the defective Supply;
- 13.2. The Supplier is, however, not excused from specifically performing any of its obligations in a timeous manner under this Contract, whether express or implied and:

13.2.1. if the Supplier fails to carry out any such obligation with reasonable speed or efficiency; and

13.2.2. persists in such default after receiving reasonable notice from the Client in Writing to do so;

the Client shall be entitled to seek adequate relief or compensation for any direct damages caused by the Supplier's failure to carry out its obligations under this Contract.

13.3. Supplier shall indemnify the Client and its Affiliated Companies and hold them harmless from and against any liability for death, illness or injury to any third Party or for loss of or damage to any third Party's property and against all claims, demands, proceedings and causes of action resulting therefrom and arising out of any negligent act or default on the part of the Supplier, its servants or agents in the performance of its obligations hereunder.

13.4. Supplier shall indemnify Client and its Affiliated Companies and hold them harmless from and against any and all liability and in respect of all losses, damages, costs, claims or causes of action arising out of:

13.4.1. Sickness, injury or death of any of its staff howsoever caused including where such is caused by the negligence of the Client and its Affiliated Companies;

13.4.2. the imposition of any liability or penalty upon the Client or any of its Affiliated Companies by the local authority in the country of the Project or of any other country where the Supply is being delivered by reason of any alleged violation of the laws of any of those countries arising out of the acts or omissions of the Supplier or its personnel, servants or agents whilst delivering the Supply or any part thereof; and

13.4.3. physical loss of or damage to the property of the Supplier or the property or personal effects of its personnel excluding where such is caused by the negligence of Client;

13.4.4. breach of any warranty provided by the Supplier under this Contract in relation to the Supply.

13.5. Any action for breach of this Contract or claim brought by the Supplier against the Client and any of its Affiliated Companies must be commenced no later than six (6) months after expiration or termination of the Term or the completion of the Supply whichever is earlier (the "Claim Period"). If the Supplier fails to bring such action within the Claim Period, then the Supplier shall be deemed to have waived whatever rights it may have had in relation to such cause of action including all legal and equitable remedies.

14. EXTENSION OF TIME

If at any time during the Term of the Contract, the Supplier or its subcontractor(s) should encounter conditions impeding the timely delivery of the Supply, the Supplier shall notify the Client in writing of the facts of delay, its likely duration and its cause(s). As soon as practicable after receipt of the Supplier's notice, the Client shall evaluate the situation and may at its own discretion extend the Supplier's time for delivery, with or without the liquidated damages, in which case the extension shall be ratified by the Parties by amending the Contract in due course.

15. PROHIBITED ACTS

15.1. The Supplier and the Client represent, warrant, agree and undertake to each other that:

- 15.1.1. neither the Supplier, any of its affiliates, owners, officers, directors, employees or other representatives at the Effective Date, has offered, promised, given, authorized, solicited or accepted any undue pecuniary or other advantage of any kind (or implied that they will or might do any such thing at any time in the future) in any way connected with the Contract and that it has taken reasonable measures to prevent subcontractors, agents or any other third parties, subject to its control or determining influence, from doing so;
- 15.1.2. neither the Supplier, any of its affiliates, owners, officers, directors, employees or other representatives during the Term of this Contract will perform any Prohibited Act, in relation to provision of the Supply under this Contract;
- 15.1.3. neither the Client, any of its Affiliates, owners, officers, directors, employees or other representatives during the Term of this Contract will perform any Prohibited Act, in relation to provision of the Supply under this Contract;
- 15.1.4. both the Supplier and the Client covenant that should it become aware of any Prohibited Act relating to this Contract, it shall promptly notify the other Party and shall cooperate in good faith with any concerns of such nature of which it may be notified by the other Party. Either Party may by written notice require the other Party to remove (or cause to be removed) anyone who is involved in the performance of this Contract, who in the reasonable opinion of the notifying Party, has committed or may be involved in the committing of a Prohibited Act.

16. NON-SOLICITATION

16.1. The Client shall not, for the duration of this Contract until six (6) months from the date of termination of this Contract, specifically and intentionally target the Supplier's staff with a view to entice or encourage them to leave the employ of the Supplier.

16.2. The Supplier shall not, for the duration of this Contract until six (6) months from the date of termination of this Contract, specifically and intentionally target the Client's staff with a view to entice or encourage them to leave the employ of the Client.

17. CONFIDENTIALITY

- 17.1. The Parties to this Contract have already acquired and shall continue to acquire knowledge of, and access to Confidential Information as a result of their business interactions in terms of this Contract.
- 17.2. The Parties undertake not to disclose, publish, release, transfer or otherwise make available Confidential Information or any information relating to operations and/or the affairs of the Parties in any form to, or for the use of or benefit of any other person or entity without the prior written consent of the other Party (which consent shall not be unreasonably withheld).
- 17.3. The Parties agree to keep all Confidential Information confidential and to disclose it only to their officers, directors, employees, consultants and professional advisers who have a need to know (and then only to the extent that each such person has a need to know), are aware that the Confidential Information should be kept confidential and have been directed by the disclosing Party to keep the Confidential Information confidential and have undertaken to keep the Confidential Information confidential.
- 17.4. During and after the Term, other than as ordered or required by law or in the course of administrative or judicial proceedings, or in accordance with the requirements of any applicable stock exchange, the Supplier shall not issue, and shall procure that its affiliates, successors, assignees, employees, representatives, directors, officers, agents, advisors, contractors, suppliers and subcontractors of any tier (the "**Supplier Group**") do not issue, any press release or make any other public announcement relating to the transactions contemplated by this Contract without the prior written approval of the Client as to the contents and the manner of presentation and publication of such press release or public announcement. During and after the Term, the Supplier shall not use or display and shall procure that the Supplier Group shall not use or display Client's or the owner of the Project Site's name, or the Project Site or use any pictures, photographs, audio and video recordings, digital images showing, indicating or containing the Client, the Supply or the Project Site in any website, social or professional media or network, television programs, advertising, publicity, sales and marketing brochures, books, magazines, CDs, DVDs, tapes, or any other print or electronic media or other publications anywhere in the world without Client's written consent.
- 17.5. The foregoing obligations shall not apply to any information which:
- 17.5.1. is lawfully in the public domain at the time of disclosure;
- 17.5.2. subsequently and lawfully becomes part of the public domain by publication or otherwise and other than in breach of this Contract;
- 17.5.3. subsequently becomes available to the receiving Party from a source other than the disclosing Party, which source is lawfully entitled without any restriction on disclosure to disclose such Confidential Information; or

17.5.4. is disclosed pursuant to a requirement or request by operation of law, regulation or court order.

18. TERMINATION

- 18.1. The Supplier shall by Written notice to the Client have the right forthwith to terminate this Contract, without prejudice to any claim which the Supplier may have against the Client for the Contract Price due and payable, where:
- 18.1.1. the Client fails to pay any amount due under this Contract (save to the extent that such amount is disputed in accordance with the terms of this Contract) within sixty (60) days of receipt of notice to the Client requiring payment of such amount; or
- 18.1.2. the Client becomes insolvent.
- 18.2. The Client shall by Written notice to the Supplier have the right forthwith to terminate this Contract, without prejudice to any claim which the Client or any of its Affiliated Companies may have against the Supplier for amounts due and payable, where:
- 18.2.1. the Supplier fails to pay any amount due under this Contract within thirty (30) days of receipt of notice to the Supplier requiring payment of such amount; or
- 18.2.2. the Supplier becomes insolvent;
- 18.2.3. the Supplier fails to provide the Supply in accordance with this Contract or the Purchase Order due to the reasons attributable to the Supplier ;
- 18.2.4. at any time and for any reason the Supplier does not perform its obligations under the Contract or the Purchase Order or its Affiliated Company (acting in its sole discretion); or
- 18.2.5. the cap on liquidated damages set out in Clause 11 is exceeded.
- 18.2.6. the Supplier has engaged, is engaging and/or is reasonably inferred to be engaging in a Prohibited Act or any practice that could reasonably be expected to result in breach, or is in breach of Clause 23; and
- 18.2.7. The Supplier fails to comply with any of its obligations under the Contract or the Purchaser Order.
- 18.3. The Client may terminate this Contract for convenience at any time during its Term in accordance with this Clause 18.3. In the event the Client elects to do so, the Client shall give to the Supplier sixty (60) days' notice in writing, at the end of which period this Contract shall terminate. Upon termination of this Contract pursuant to this Clause 18.3, the Client shall pay the Supplier in respect of the Supply and inventory delivered (which

shall include the items procured under the issued POs and/ or otherwise procured at the written request of the Client) satisfactorily performed up to the date of termination. In no event shall the Supplier be entitled to any prospective profits, consequential or indirect losses or any damages because of such termination.

- 18.4. On the date of termination of this Contract pursuant to Clause 18, the Supplier shall discontinue provision of the Supply and shall wholly comply with the Client's instructions regarding such termination.
- 18.5. The terms and conditions of this Contract shall remain in full force and effect until such time the Contract is terminated or amended in accordance with the terms hereof, save Clause 13 (Liability and Indemnity), Clause 16 (Non-solicitation), Clause 17 (Confidentiality), Clause 18 (Termination) and Clause 19 (Dispute Resolution), which will survive the termination of this Contract.

19. DISPUTE RESOLUTION

- 19.1. The Parties shall use their best endeavors and efforts to resolve, through mutual consultation and without involving third parties, any disputes which may arise under, out of, or in connection with or in relation to this Contract.
- 19.2. If, following such mutual consultation and negotiation, the dispute still remains unresolved and outstanding within ten (10) days after the date of referral in Writing, the dispute shall, by written notice by either Party to the other, be referred to the non-exclusive jurisdiction of the Courts of Dubai, United Arab Emirates, in accordance with the remaining provisions of this Clause 19.
- 19.3. This Clause 19 will continue to be binding on the Parties notwithstanding any termination or cancellation of the Contract.

20. FORCE MAJEURE

- 20.1. Neither Party shall be liable for any failure to fulfil its obligations under this Contract if and to the extent that such failure is caused by any circumstances beyond its reasonable control and not of its making, including but not limited to flood, fire, earthquake, war, tempest, hurricane, industrial action, floods, government restrictions or acts of God.
- 20.2. If the force majeure shall continue for more than thirty (30) days, the non-invoking Party shall be entitled to cancel this Contract on the expiry of such period with immediate effect on written notice, but shall not be entitled to claim damages against the invoking Party as a result of the delay or failure in the performance of any obligations hereunder due to or resulting from the force majeure, except as otherwise provided in this Contract.

21. ADDRESSES FOR NOTICES AND LEGAL PROCESS

- 21.1. Each Party choose as its address for all purposes under this Contract (“**Chosen Address**”), whether in respect of serving any court process or other documents, giving any notice or making any other communications of whatsoever nature (“**Notice**”), the following:

- 21.2. Any Notice required or permitted to be given in terms of this Contract shall be valid and effective only if in Writing, but it shall be competent to give notice by email.
- 21.3. Any Party may by Notice to the other Party, change its Chosen Address to another physical address, fax number or email address, provided that the change shall only become effective on the 7th (seventh) day of receipt (or deemed receipt) of the Notice by the other Party.
- 21.4. Any Notice:
- 21.4.1. delivered by hand to a responsible person during ordinary business hours at its Chosen Address, shall be deemed to have been received on the day of delivery;
 or
- 21.4.2. sent by email to its Chosen Address, shall be deemed to have been received on the date of dispatch and at the time recorded by the computer/device used by the sender of the email (unless the contrary is proven).

- 21.5. Notwithstanding anything to the contrary herein contained, a Notice actually received by a Party shall be an adequate written notice or communication to it notwithstanding that it was not sent to or delivered at its Chosen Address.

22. APPLICABLE LAW

Unless expressly stated otherwise herein, this Contract shall be governed by the laws of the Emirate of Dubai and the Federal laws of the United Arab Emirates.

23. COMPLIANCE

- 23.1. The Supplier represents, warrants, agrees and undertakes to ensure that neither it nor any of its affiliates, owners, officers, directors, employees or agents, during the term of this Contract, have engaged in any activity which would violate any anti-bribery legislation (including breach of any United States foreign corrupt practices legislation or United Kingdom bribery legislation), anti-money laundering legislation or counter-terrorism, crime, security or similar legislation, or financial or trade sanctions, in any applicable jurisdiction.
- 23.2. The Supplier shall not engage in any practices that could reasonably be expected to result to the best of Supplier's knowledge, the Supplier or the Client being in breach of any financial or trade sanctions in respect of any transaction contemplated by the Contract.
- 23.3. Supplier shall ensure that appropriate controls and safeguards are in place designed to prevent any action being taken that would be contrary to the provisions in this clause 23 (*Compliance*).
- 23.4. The Supplier represents and warrants to the Client that, as at the date of the Contract, the Supplier is not a Related Party.
- 23.5. The Supplier covenants that should it become aware that the Supplier is, shall become, a Related Party, **or** an event will arise or has arisen which results in one or more of the circumstances set out under the definition of Related Party it shall promptly notify the Client or the owner of the Project Site. Upon any such notification or if the Client notifies Supplier that, in the Client's opinion, the Supplier is a Related Party, the Supplier shall cooperate in good faith with the Client and its representatives and shall respond promptly and in reasonable detail to any notice from the Client.
- 23.6. The Supplier covenants that should it become aware of any violation of this clause 23 (*Compliance*) or any other legal requirement or law, it shall promptly notify the Client. Upon any such notification or if the Client notifies the Supplier of its concern that there has been a violation of this clause 23 or any other legal requirement or law, the Supplier shall cooperate in good faith with the Client and its representatives in determining whether such a violation has occurred, shall respond promptly and in reasonable detail to any notice or

request from the Client and shall furnish support for such response upon the Client's request.

- 23.7. The Supplier shall maintain adequate internal controls and accurate books and records to ensure compliance with its obligations under this clause 23. Upon any notice from the Client, the Supplier shall respond promptly and in reasonable detail to any such notice or request from the Client to verify compliance with such obligations.
- 23.8. Notwithstanding the provisions of clause 13 (Liability and Indemnity), the Supplier shall indemnify to the fullest extent possible and hold the Client and its Affiliates, owners, officers, directors, employees, agents, contractors and other representatives acting on behalf of the Client (collectively, the "**Relevant Parties**") harmless against any and all claims, costs, expenses (including court fees and legal fees) or actions which the Relevant Parties may suffer or incur as a result of or in connection with any non-compliance with this clause 23 by the Supplier or any of its affiliates, owners, officers, directors, employees, agents, subcontractors or other representatives acting on behalf of the Supplier.

24. GENERAL

24.1. Remedies

No remedy conferred by this Contract is intended to be exclusive of any other remedy which is otherwise available in law. Each remedy shall be cumulative and in addition to every other remedy given hereunder or existing in law. The election of any one or more remedy by any one of the Parties shall not constitute a waiver by such Party of the right to pursue any other remedy.

24.2. Entire Contract

This Contract constitutes the entire agreement between the Parties regarding the subject matter hereof, and supersedes any prior understandings or prior agreements, oral or written, in relation to said subject matter. Save as otherwise expressly provided, no modification, amendment or waiver of any of the provisions of this Contract shall be of any force or effect unless reduced to Writing and signed by both Parties.

24.3. No Waiver

No extension of time or other indulgence which either Party may allow to the other shall constitute a waiver by the former of his/her rights to require the latter to comply with his/her obligations strictly in accordance with the provisions of this Contract.

24.4. Severability

Each and every provision of this Contract shall be deemed to be separate and severable from the remaining provisions of this Contract. If any of the provisions of this Contract are found by a court of competent jurisdiction to be invalid and/or unenforceable, then the remaining provisions of this Contract shall remain of full force and effect.

24.5. Survival of Rights, Duties and Obligations

The termination of this Contract for any cause shall not release a Party from any liability which at the time of termination has already accrued to such Party, or which thereafter may accrue in respect of any act or omission prior to such termination.

24.6. Independent Advice

Each of the Parties hereby acknowledge and agree that:

24.6.1. IT has been free to secure independent legal and other professional advice as to the nature and effect of all the provisions of this Contract, and that they have either taken such independent advice, or have dispensed with the opportunity to do so; and

24.6.2. all of the provisions of this Contract are fair and reasonable and are in accordance with both Parties intentions.

24.7. Successors Bound

This Contract shall be binding on and shall take effect for the benefit of the successors and assigns and personal representatives, as the case may be, of each of the Parties. Nothing in the Contract is intended to, or shall be deemed to, establish any partnership or joint venture between the Parties, constitute either Party the agent of the other Party, nor authorize either Party to make or enter into any commitments for or on behalf of the other Party.

24.8. No Partnership

Nothing in the Agreement is intended to, or shall be deemed to, establish any partnership or joint venture between the Parties, constitute either Party the agent of the other Party, nor authorize either Party to make or enter into any commitments for or on behalf of the other Party.

24.9. Assignment

Neither Party may assign, transfer or novate any or all of its rights or obligations under this Agreement, save that the Client may assign, transfer or novate its rights to an Affiliate, the owner of the Project Site or its lenders.

24.10. Supplier's Representations and Contractual Warranties

The Supplier acknowledges that the Client has entered into this Contract in reliance on the representations and contractual warranties made by the Supplier in the following terms, which expressly represents and warrants to the Client that:

- (a) the Supplier is duly organized, validly existing and in good standing under the laws of the country of its incorporation and is qualified in good standing in each other

jurisdiction where a failure so to qualify would have a material adverse effect upon the business or financial condition of the Supplier;

- (b) the Supplier has power to conduct its business as presently conducted, to own or hold under lease its assets and to enter into and perform its obligations under this Contract and to consummate the transactions contemplated by this Contract;
- (c) the execution, delivery and performance of this Contract and the consummation of the transactions contemplated by it have been duly authorized by all necessary or appropriate action on the part of the Supplier, and all necessary authorizations have been or will be duly obtained by the Effective Date;
- (d) neither the execution and delivery by the Supplier of this Contract nor the performance of its obligations under it will contravene or constitute a default under any provision contained in the Law, judgment, order or authorization to which the Supplier is subject or by which the Supplier or any material part of its assets is bound or affected, or in any agreement or instrument to which it is a party;
- (e) this Contract will constitute legal, valid, binding and enforceable obligations of the Supplier; and
- (f) no judgment has been given in legal proceedings and no arbitral or administrative award has been given and there are not pending or, to the knowledge of the Supplier, threatened, any litigation, arbitration or administrative actions or proceedings before a court, arbitrator or competent authority which by itself or together with any other such proceedings, if determined adversely to the Supplier, would materially and adversely affect the ability of the Supplier to perform its obligations under this Contract.
- (g) The Supplier warrants that the Supply, design, materials, documents and methods provided by the Supplier, do not infringe any Intellectual Property rights of any person

24.11. Data and Cybersecurity

The title of all data obtained from or generated by or in relation to the Supply howsoever such data is described and in whatsoever form that such data is obtained or generated shall be solely owned by the Client (the "Supply Data") and the Supplier shall ensure that the Client retains and maintains a permanent, uninterrupted, unrestricted and unconditional access to the Supply Data and shall make available to the Client any of such Supply Data immediately upon Client's first request. The Supplier shall cooperate and provide the Client with all assistance necessary to allow the Client such permanent, uninterrupted, unrestricted and unconditional access to the Supply Data at no cost of the Client. The Supplier hereby irrevocably and unconditionally accepts, acknowledges and agree that:

- (a) The Client is free to use, amend, alter, modify, develop, enhance, upload, store and take all other actions and perform any other acts as the Client may deem including but not limited to development or generation of any algorithms, products,

plans or any other Intellectual Property in consideration to the Contract Price only (the "Client Utilization"); and

- (b) waives any and all rights to (a) object with regards to any and all of Client Utilization, and (ii) claim, demand, or request any compensation for any and all of the Client other than the Contract Price only;
- (c) any and all new Intellectual Property conceived or created by the Client arising from or in relation to the Supply Data or Client Utilization, will be owned exclusively by, and vest in, the Client without any compensation to the Supplier other than payment of the Contract Price. The Supplier will, at its own costs, deliver any requested documentation and will give the Client such other reasonable assistance as necessary to achieve that result;
- (d) If the Supplier provides the Client with any feedback or suggested improvements to, then notwithstanding any other obligation, the Client has the right to use and implement such suggestions, without compensation to the Supplier other than the payment of the Contract Price by the Client, and as between the Parties, the Client will solely own products and services developed by or for the Client from such suggestions without any compensation to the Supplier save for the payment of the Contract Price by the Client.
- (e) the Supplier will defend and indemnify the Client against any breach by the Supplier of this Clause 24.8.

For the purpose of this Clause 24.8 (Data and Cybersecurity), reference to the Client includes the Client's subsidiaries, Affiliates, employees, officers, consultants, advisors, subcontracts, and experts.

If any transactions contemplated by this Contract require the Supplier to access or connect to any network, system, software, or other technology of the Client, its Affiliates, contractors or agents ("Client's IT Systems and Data"), such access or connection will be used for the limited purposes set forth in this Contract. The Supplier warrants that it has administrative, technical and physical safeguards in place that comply with all laws and regulations of the United Arab Emirates in relation to cybersecurity, use of internet or computerized systems (the "Local Regulations"). In the event that the Supplier becomes aware of any actual or suspected breach of the Client's IT Systems and Data, or any breach of any of Local Regulations, the Supplier shall immediately inform the Client of such breach and take appropriate steps to contain or mitigate the breach.

The Supplier shall fully indemnify the Client any breach to the Client's IT Systems and Data as a result of the Supplier's acts, omissions, negligence or willful misconduct
